The Planning Meeting of the Borough of Wrightsville governing body convened at 6:31pm on Monday, January 16, 2017. Vice- President Bolton called the meeting to order.

Mel McDonald:

Mrs. McDonald wanted clarification from Chief Hege on who initiated a traffic stop with Mr. G. Young. Chief Hege indicated that he was the individual that initiated the traffic stop and not Councilman Shannon.

**BOROUGH COUNCIL COMMITTEE REPORTS:**

*Administration & Finance:*

Councilman Gromling made a motion to advertise for an office assistant with salary costs to be shared with Wrightsville Borough Municipal Authority. Councilman White seconded the motion. All in favor. The motion carried with a unanimous vote.

*Public Works:*

Engineer Klinedinst presented council with plans and cost associated with Locust Street Project, 300-500 blocks. Engineer Klinedinst indicated that approximate cost for project would be \$500,000. Currently the borough has a grant for \$200,000. Bidding process will most likely start in January 2018.
