

ORDINANCE NO. 2012-4

AN ORDINANCE OF THE BOROUGH OF WRIGHTSVILLE, YORK COUNTY, PENNSYLVANIA, AMENDING CHAPTER 15 (MOTOR VEHICLES AND TRAFFIC), PART 2 (TRAFFIC REGULATIONS) SECTION 201 (MAXIMUM SPEED LIMITS ESTABLISHED ON CERTAIN STREETS) OF THE BOROUGH OF WRIGHTSVILLE CODE OF ORDINANCES TO REQUIRE SPEED LIMITS ON VARIOUS STREETS IN THE BOROUGH

WHEREAS, the Borough of Wrightsville requested the York County Planning Commission, Transportation Engineering Services, to perform seventeen traffic and engineering studies to determine whether the present speed limit postings were safe and reasonable; and

WHEREAS, seventeen traffic and engineering studies dated between August 10 and August 20, 2007, supported a 25 MPH speed limit on several streets within the Borough, and are attached hereto and incorporated by reference as Exhibit A; and

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Wrightsville, York County, Pennsylvania, as follows:

SECTION 1. Chapter 15 (Motor Vehicles and Traffic), Part 2 (Traffic Regulations) Section 201 (Maximum Speed Limits Established on Certain Streets) of the Borough of Wrightsville Code of Ordinances shall be revised to add the following:

Vine Street	25	From Hybla Road to 2 nd Street
Walnut Street	25	From 7 th Street to Front Street
North 7 th Street	25	From Hellam Street to Hybla Road
South 2 nd Street	25	From Hellam Street to Willow Street
North 3 rd Street	25	From Hellam Street to Vine Street
South 3 rd Street	25	From Hellam Street to Orange Street

Orange Street	25	From 6 th Street to Front Street
Maple Street	25	From 6 th Street to Front Street
North 4 th Street	25	From Hellam Street to Vine Street
Cherry Street	25	From end to 3rd Street
North Front Street	25	From Hellam Street to Borough Line (North)
Chestnut Street	25	From Front Street to the school
Willow Street	25	From Front Street to Barnes Avenue
Lemon Street	25	From Front Street to Barnes Avenue
6 th Street	25	From Walnut Street to Borough Line
North 2 nd Street	25	From Hellam Street to end
Locust Street	25	From 9 th Street to Front Street

SECTION 2. This Ordinance shall be effective five (5) days after adoption.

SECTION 3. Any Ordinance conflicting or inconsistent with this Ordinance is repealed to the extent of such conflict or inconsistency.
