**ORDINANCE NO. 2014 -3**

**AN ORDINANCE AUTHORIZING EXECUTION OF AN INTERGOVERNMENTAL  
COOPERATION AGREEMENT FOR THE IMPLEMENTATION OF THE  
YORK COUNTY REGIONAL CHESAPEAKE BAY POLLUTANT REDUCTION PLAN**

WHEREAS, the York County Regional Chesapeake Bay Pollutant Reduction Plan (CBPRP) is a tool to help the County meet its Draft Pollutant Reduction Targets for the Chesapeake Bay as established by the PA Department of Environmental Protection; and

WHEREAS, a CBPRP is a Permit requirement for Municipal Separate Storm Sewer System (MS4) permit holders in York County; and

WHEREAS, the Borough of Wrightsville participated in the development of the Regional CBPRP; and

WHEREAS, the Borough of Wrightsville has adopted a Resolution to Opt-In to the Regional Plan and make a financial commitment toward its implementation; and

WHEREAS, the Intergovernmental Cooperation Law, 53 Pa.C.S. §2301-2315, permits municipalities to enter into intergovernmental cooperation agreements; and

WHEREAS, the purpose of this Ordinance is to authorize the Borough of Wrightsville to enter into an Intergovernmental Cooperation Agreement for the Implementation of the York County Regional CBPRP, a copy of which is attached hereto as Exhibit "A" and made a part thereof;

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Borough Council of the Borough of Wrightsville as follows:

**SECTION 1: ADOPTION OF AGREEMENT**

A. The CBPRP Intergovernmental Cooperative Implementation Agreement ["Agreement"], a true and correct copy of which is attached hereto as Exhibit "A" is hereby adopted.

B. The Agreement contains the conditions of agreement for the Regional CBPRP, the duration of the term of the Agreement, the purpose and objectives of the Agreement, the manner and extent of financing the Agreement, and the organizational structure of the Regional CBPRP.

SECTION 2: AMENDMENTS TO THE AGREEMENT

Any and all amendments or modifications to the Agreement, including the termination of the Agreement, shall not require passage of another Ordinance, but shall be authorized and confirmed by the adoption of a resolution by the Borough Council of the Borough of Wrightsville.

BE IT DULY ENACTED AND ORDAINED, this 6<sup>th</sup> day of October, 2014, by the Borough Council for the Borough of Wrightsville.
