# WRIGHTSVILLE BOROUGH COUNCIL REGULAR MEETING

## MONDAY, APRIL 2, 2018

Council President White called the Regular Meeting of the Wrightsville Borough governing body to order at 6:37pm and led the salute to the American Flag.

#### **PATRONS:**

#### Mel McDonald:

Mrs. McDonald once again expressed her displeasure to trash cans being left all over sidewalks throughout the borough. She stated that trash can and recycling containers need to be back to property away from the street. Mrs. McDonald stated that the cellar door at Fakey's property needs to be secured immediately before someone is injured.

#### Ben Craddock:

Mr. Craddock, Project Manager, Wrightsville Borough relayed to those in attendance that Wrightsville Borough has been awarded a \$356,350 Growing Greener grant to help with green infrastructure improvements at Riverfront Park.

#### **ACTION ITEMS:**

Mayor Albert issued an Oath of Office to the following Fire Police members: Captain Ed Keller, Wilmer Oakes, James Haugh, Bradley Ream, Philip Lehman and Derrick Haugh.

Mayor Albert presented Fire Department Chief, Chad Livelsberger and members of Wrightsville Fire and Rescue Company 41 a commendation of service thanking them for their outstanding, professional and unwavering dedication to the duties of volunteer firefighters. Mayor Albert his sincere appreciation to all members of the department for their service.

Engineer Klinedinst presented a brief MS4 presentation to those in attendance. Engineer Klinedinst stated that Wrightsville Borough has been approved for a waiver for MS4 reporting from 2018-2023. Engineer Klinedinst indicated that a new waiver will need to be applied for in 2023. MS4 operations still need to be monitored but reporting to DEP is not required. Record keeping is vital in MS4 procedures.

Vice President Gromling made a motion to approve and adopt Resolution 2018-17, a resolution approving Ben Craddock, Project Manager to submit DCNR grant for Riverfront Park , project title- Riverfront Park Visitors Amenities. Councilman Bair seconded the motion. All in favor. The motion carried with a unanimous vote.

Vice President Gromling made a motion to approve County of York, Department of Emergency Services Mobile Data Computer Agreement with Wrightsville Borough Police Department, effective April 1, 2018 through March 31, 2023. Councilman Bair seconded the motion. All in favor. The motion carried with a unanimous vote.

Councilman McDonald made a motion to close the following streets on Sunday, May 6, 2018 from 7:00am to 3:00pm: 2<sup>nd</sup> St. from 100 block of Garden Avenue to Chestnut St. for Wrightsville Borough Fire Department Chicken BBQ Fundraiser. Vice President Gromling seconded the motion. All in favor. The motion carried with a unanimous vote.

Councilman McDonald made a motion to close the following streets on Monday, May 28, 2018 from 11:30am to 1:00pm: Hellam St. from S. 2<sup>nd</sup> St. to 8<sup>th</sup> St., S. 2<sup>nd</sup> St. from Hellam St. to Orange St., Chestnut St. from S. 3<sup>rd</sup> St. to Front St., Garden Avenue from Barnes Avenue to Howard Avenue for Memorial Day Parade. Vice President Gromling seconded the motion. All in favor. The motion carried with a unanimous vote.

President White passed the gavel to Vice President Gromling. President White made a motion to approve payment in the amount of an additional \$6.00 per hour to Adam Schaum as discretionary compensation for services as the Officer in Charge for Wrightsville Borough Police Department. Payment will be retro active to January 1, 2018. Councilman McDonald seconded the motion. All in favor. The motion carried with a unanimous vote.
