WRIGHTSVILLE BOROUGH COUNCIL REGULAR MEETING MONDAY, AUGUST 6, 2018

Council President White called the Regular Meeting of the Wrightsville Borough governing body to order at 6:33pm and led the salute to the American Flag.

PATRONS:

Irvin Sholl:

Mr. Sholl relayed to those in attendance his concern for the abundant amount of feral cats in 600 block of Walnut St. Mr. Sholl would like council to take action on this amount to possibly reduce the amount of feral cats in area.

Jon Cox- Eckert, Seamans, Bond Counsel- USDA Stormwater Interim Financing: Mr. Cox provided council members with an update on timeline of financing. Currently approved is a pre-construction line of credit to pay soft costs associated with project. Engineer costs that

is a pre-construction line of credit to pay soft costs associated with project. Engineer costs that have been accrued to date have not been paid awaiting interim financing. Engineer design costs will total approximately \$100K. Interim financing has been acquired through ACNB Bank and they have agreed to hold interest rate for length of loan. A RUS (Rural Utility Service) Bond is required by USDA for a project of this scope. Due to some unforeseen circumstances and time lines of planned PennDOT projects the Ordinance that was approved on July 2, 2018 has to be rescinded and repealed by council. RUS has agreed to hold commitment open for 3 years to allow for projects to be completed as planned.

Vice President Gromling made a motion to rescind and repeal Ordinance 2018-1 approved by Wrightsville Borough Council on July 2, 2018. Councilman Kirkessner seconded the motion. All in favor. The motion carried with a unanimous vote.

ACTION ITEMS:

Vice President Gromling made a motion to adopt Ordinance 2018-2 of the Borough of Wrightsville authorizing and securing the issuance of a general note or bond , in the maximum principal amount of \$150,000, pursuant to the Pennsylvania Local Government Unit Debt Act, for preconstruction costs of a project consisting of designing and constructing improvements to

its stormwater management facilities. Councilman McDonald seconded the motion. All in favor. The motion carried with a unanimous vote.

Street Closure Requests:

Councilman Smith made a motion to close Garden Avenue from S. 2nd Street to Howard Avenue on Saturday, August 11, 2018 from 2:00pm-4:30pm for Wrightsville American Legion Post 469 benefit ride for Veteran Canine Services. Councilman Bair seconded the motion. All in favor. The motion carried with a unanimous vote.

Councilman Smith made a motion to close N. Front Street from Walnut Street to 2nd Street, 2nd Street from Walnut Street to Hellam Street and bridge closure to 2nd Street on Friday, October 5, 2018 from 5:00pm-9:00pm for Luekemia and Lymphoma Light the Night Walk. Councilman Bair seconded the motion. All in favor. The motion carried with a unanimous vote.

Councilman McDonald made a motion to close Hellam Street from 2nd Street to Route 462 Bridge on Saturday, October 6, 2018 from 4:00am-6:00pm for Susuquehanna Valley Chamber of Commerce Bridge Bust. VP Gromling seconded the motion. All in favor. The motion carried with a unanimous vote.

Councilman Smith made a motion to close Hellam Street from 4th Street to Route 462 Bridge on Saturday, November 3, 2018 from 7:00am-10:30am for Susquehanna Valley Chamber of Commerce MAG Fall Flash. VP Gromling seconded the motion. The motion was passed with a 4-2 vote. President White and VP Gromling were opposed to the motion.
