# WRIGHTSVILLE BOROUGH COUNCIL REGULAR MEETING MONDAY, JUNE 4, 2018

Council President White called the Regular Meeting of the Wrightsville Borough governing body to order at 6:34pm and led the salute to the American Flag.

#### **PATRONS:**

#### Laurie Lehman:

Miss Lehman provided council with a petition of residents who are opposed to a mini casino being built in area. Miss Lehman relayed to those in attendance that Mark Myers, Hellam Township Supervisor, confirmed that President White and VP Gromling did attend meeting at Hellam Township and both gentlemen are in favor of mini casino being built.

#### **Brock Bolton:**

Mr. Bolton relayed to those in attendance that he was not in attendance to argue with anyone, however, he wanted his voice to be heard. Mr. Bolton expressed that the mini casino, if built, would be built to the left of his home and he would not like that for his siblings and family. He expressed that he likes living in small town Wrightsville. He expressed that a mini casino being built would increase crime and drug traffic and he does not want that for the children in area.

# Connie Radziewicz:

Miss Radziewicz was returning for an update to place teal ribbons on poles along Hellam Street in September to promote Turn the Town Teals for ovarian cancer awareness. Councilman McDonald indicated that he has been communicating with PPL to obtain approval. Councilman McDonald and Miss Radziewicz will work jointly on this project.

Councilman Smith made a motion to move forward with proposal for police coverage with Hellam Township. Councilman Bair seconded the motion. All in favor. The motion carried with a unanimous vote.

Councilman Smith made a motion to approve the May 7, 2018 Regular Meeting Minutes pending corrections be made to notes reflecting council's responses concerning the road closure on Saturday, May 26, 2016 for re-dedication ceremony held in Columbia Borough. Councilman McDonald seconded the motion. All in favor. The motion carried with a unanimous vote.

Councilman Bair made a motion to approve the May 21, 2018 Planning Meeting Minutes. Councilman Kirkessner seconded the motion. All in favor. The motion carried with a unanimous vote.
