The Planning Meeting of the Borough of Wrightsville governing body convened at 6:32PM on Monday, February 19, 2018. Council President White called the meeting to order and led the salute to the American Flag.

**PATRONS:**

Ed Sipes:

Mr. Sipes relayed to those in attendance that a Mifflin House rally is being held at John Wright on Wednesday, March 21, 2018 from 6pm to 8pm. The rally is a public event and all are welcome to attend. Historic Wrightsville will host Old Towne Night on Friday, March 23, 2018 at 6pm.

Mr. Sipes relayed to those in attendance that the Eastern York Work Camp currently has 60 homes in Eastern York School District that they will be assisting with minor home repairs at no cost to property owners.

Mel McDonald:

Mrs. McDonald asked council members when the cellar door at Fakey's will be fixed properly. President White relayed that property owners have been cited by the District Magistrate and processes are being followed according to the property maintenance codes.

Jim Markley:

Mr. Markely asked council their thoughts and suggestions about the possibility of holding a public yard sale in Riverfront Park and inviting residents to participate in then event. Vice President Gromling asked Mr. Markely to gather dates for proposed event and present them to council at their next meeting for further consideration.

Councilman Smith made a motion to approve voluntary settlement regarding R. Hege subject to ratification. Councilman Bair seconded the motion. All in favor. The motion carried with a unanimous vote.
