Permit holder assumes responsibility to assure grounds are reasonably free of paper and debris or will be billed for said clean-up/repair. Any refuse generated will be disposed of by Lessee. Violation of rules will necessitate permit to be revoked and future use of grounds to be denied as deemed fitting by Wrightsville Borough.

Lessee agrees no alcoholic beverages will be permitted during the event, nor will any nuisance or unlawful acts be carried on upon said property.

Lessee acknowledges the right of Lessor to cancel permit agreement at any time ten days prior to the effective time of the agreement and Lessor may cancel permit immediately at any time in the event that the Lessee has not correctly or fully carried out its obligation hereunder.

Lessee agrees to pay license fee at time said permit is obtained.

Lessee shall designate a duly authorized person to act as its agent and to be upon the event premises at all times during the term of the event and accept full responsibility for carrying out the terms of this agreement.

Lessor shall not be responsible for any articles, equipment, etc belonging to Lessee that are lost, stolen or damaged.
