PLANNING MEETING AUGUST 19, 2019

The Planning Meeting of the Borough of Wrightsville governing body convened at 6:30PM on Monday, August 19, 2019. Council President White called the meeting to order and led the salute to the American Flag.

ACTION ITEMS:

Councilman McDonald made a motion to approve Resolution 2019-11, a resolution establishing a procedure to sell personal property valued at less than two thousand (\$2,000.00). Councilman Bair seconded the motion. All in favor. The motion carried with a unanimous vote.

BOROUGH COUNCIL COMMITTEE REPORTS:

Administration & Finance:

Councilman Smith relayed to council members that Mr. Warren Taylor who was in attendance at the meeting on August 5, 2019 attended the Cemetery Association meeting and was voted unanimously to become a board member with association. Councilman Smith announced work is already being completed to clean up Mount Pisgah Cemetery.

Public Works:

VP Gromling relayed to council members that the cost to replace and post new solicitation signs would increase to \$900 and not \$600 as discussed during the meeting on August 5, 2019 due to 9 signs being placed instead of 6 as originally planned.

Councilman Bair made a motion to purchase 9 solicitation signs to be installed in borough with costs to not exceed \$900. Councilman McDonald seconded the motion. All in favor. The motion carried with a unanimous vote.

Public Safety:

VP Gromling realyed to those in attendance that he and Councilman McDonald attended the most recent emergency management meeting held at Hellam Township and during that meeting it was agreed upon that a new vehicle would be purchased to be used by supervisor on duty when emergency calls are received. VP Gromling stated that the cost of the vehicle would be split between neighboring municipalities. VP Gromling stated that the cost, not provided at the current time, should be considered when preparing a budget for 2020.
