The Planning Meeting of the Borough of Wrightsville governing body convened at 6:30PM on Monday, May 18, 2020. Council President White called the meeting to order and led the salute to the American Flag.

Ed Sipes:

Mr. Sipes asked members of council for approval for Historic Wrightsville, Inc. to host food vendors on Saturday, May 23, 2020 and Sunday, May 24, 2020 from 11am-4pm at Hope United Methodist Church for fundraising event. Council had no objections pending entertainment permit was submitted to administrative office. Mr. Sipes had completed entertainment permit and submitted the permit to Secretary Hoff during the meeting.

Mr. Sipes relayed to members of council that Historic Wrightsville, Inc. received \$1200.00 for Give Local York- an event that was held remotely due to COVID-19 restrictions.

Vice President Smith made a motion to approve Municipal Yard Waste Marketing Agreement with Columbia Borough Municipal Department. Councilman Bair seconded the motion. All in favor. The motion carried with a unanimous vote.

Vice President Smith made a motion to approve temporary handicap markings at 200 Willow St. from May 26, 2020 to June 26, 2020 pending application and all supporting documents are submitted to administrative office before markings are completed. Councilman McDonald seconded the motion. All in favor. The motion carried with a unanimous vote.

Vice President presented council with a draft ordinance conveying the Borough-owned stormwater management system to Wrightsville Borough Municipal Authority. VP Smith relayed to members of council that a discussion was held during the Municipal Authority meeting on May 14, 2020 and all members of the authority are in favor of the decision of

becoming a stormwater authority as documented in the ordinance. VP Smith would like a motion made approving Solicitor Nahass to advertise ordinance for approval following the mandatory inspection period for formal adoption on June 1, 2020. Councilman Gromling noted no objections, however he would like to see job responsibilities outlined or who would be responsible for maintaining the stormwater systems and reporting requirements for MS4. After a brief discussion, Vice President Smith made a motion to authorize Solicitor Nahass to advertise Ordinance 2020-3. Councilman Bair seconded the motion. All in favor. The motion carried with a unanimous vote.
