The purpose of the program is a revitalization project to grow outdoor tourism and small businesses growth by helping them take advantage of trails in Pennsylvania, Maryland and West Virginia. Mark Platts, President – Susquehanna National Heritage Area:

Mr. Platts presented a brief presentation to those in attendance outlining a plan to the Mifflin House, a former stop of the Underground Railroad, into headquarters for the organization. Mr. Platts highlighted that the project would be a gateway visitor center for York and Lancaster counties. Mr. Platts noted that the plan; design and execution of plan would take five to eight years after the site is acquired. Mr. Platts stated this project would be a added bonus to the Trail Towns Program as presented by Mr. Nelson.
