The Planning Meeting of the Borough of Wrightsville governing body convened at 6:31pm on Tuesday, January 18, 2022. Council President Giandalia called the meeting to order and led the salute to the American Flag.

**ACTION ITEMS:**

Councilman White made a motion to adopt the 2022 Wrightsville Borough budget following the mandatory inspection period. Councilman Landis seconded the motion. Councilman White asked if VP Lyle should be voting since a family member works for the Borough noting “it’s ethic related business, nothing personal”. President Giandalia called for a roll call vote. Roll call noted as:

Motion carried, 4-2 vote

President Giandalia relayed to members of council all wage increases will be reviewed by

Personnel Committee and advised committee to meet with each employee to discuss wages.

Upon final discussion with employees, all wages will be made retro-active effective January 1,

2022. Councilman Landis agreed, noting President Giandalia’s suggestion is reasonable and all criteria should be reviewed with each employee.

Councilman Gromling made a motion to approve Resolution 2022-15 authorizing Council President and Borough Secretary to authorize and sign account documents relating to PennDOT Partner Business Agreement and to establish an account with PennDOT ECMS (Engineering

and Construction Management System). Councilman Landis seconded the motion. All in favor. The motion carried with a unanimous vote.

Councilman Landis made a motion to approve Mayor Tayne Slenker and Councilman Rick McDonald as Wrightsville Borough authorized representatives to sign off and request changes to Fire Run Cards and Responses within Wrightsville Borough municipal boundaries as outlined on official document provided from The County of York, Department of Emergency Services. Councilman Gromling seconded the motion. All in favor. The motion carried with a unanimous vote.
