Kurtis Timmer – Chief, South- Central PA Search and Rescue:

Kurtis Timmer gave an overview of the nonprofit organization's work in York County, which includes 35 volunteers, nine dogs trained to search for people, drones with infrared technology and more. They respond to missing person calls, child abduction reports and assist police and rangers at state parks in the region. Mr. Timmer noted that the South-Central PA Search and Rescue is a non-profit group that is funded by donations.

In 2022, the team responded to 27 calls, including a 12-hour search in Heidelberg Township "that ended successfully when the little girl was found," Timmer said.
