PUBLIC COMMENT:

Councilman White made a motion to approve Application for Payment No. 6 for the South Front Street Improvement Project from Reamstown Excavating & Concrete in the amount of \$189,965.60 as recommended by the engineer. VP Lyle seconded the motion. All in favor. The motion carried with a unanimous vote.

Councilman White made a motion to host trick-or-treat in Wrightsville Borough on October 31, 2023 from 6pm-8pm. VP Lyle seconded the motion. All in favor. The motion carried with a unanimous vote.
