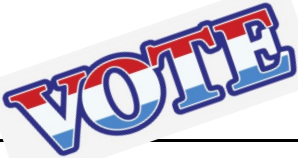

# 2023 WRIGHTSVILLE BOROUGH LEAF COLLECTION SCHEDULE

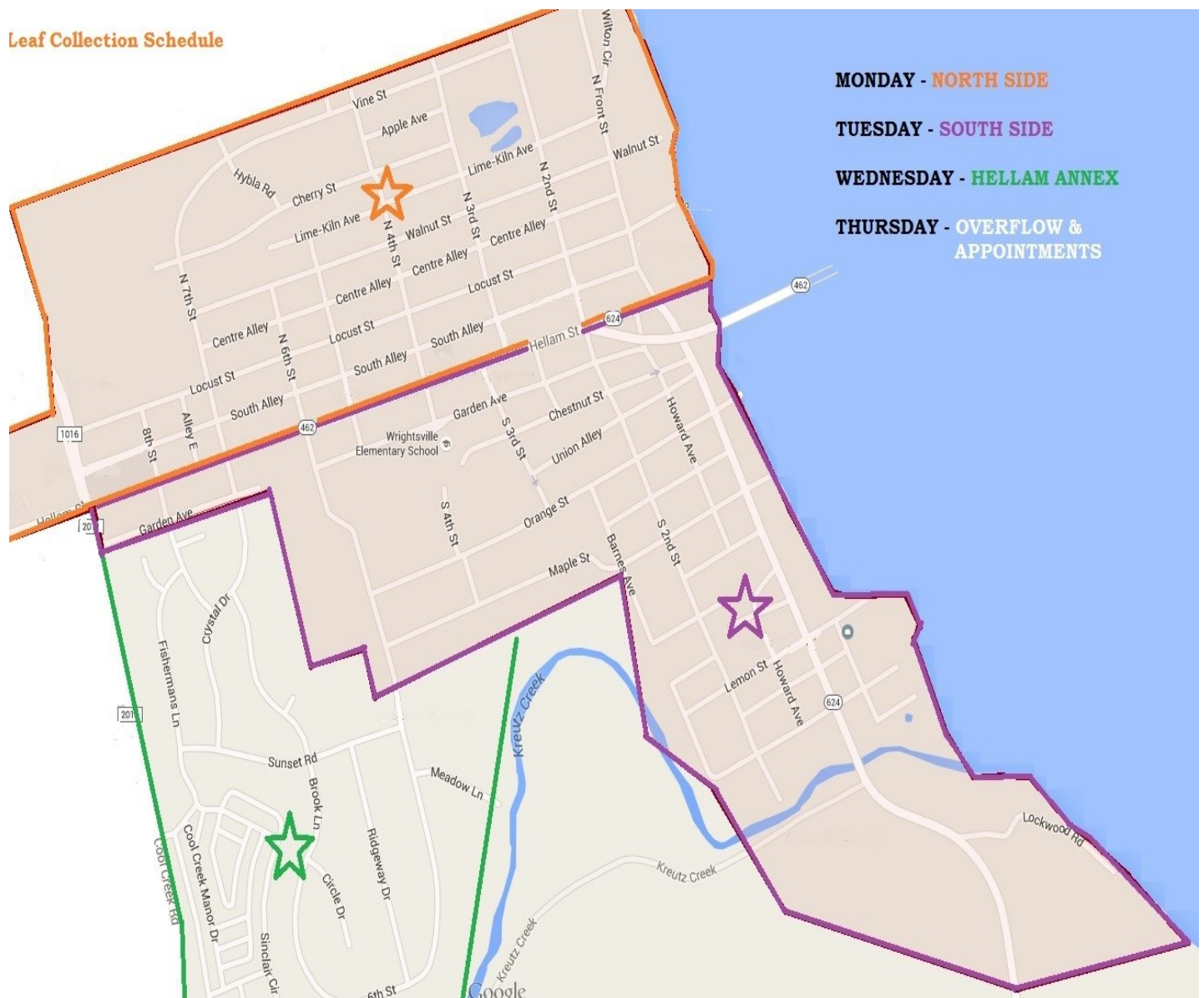
Leaf collection will begin November 13th and continue through the first week of December. The collection schedule may be adjusted due to weather conditions

When heavy rain and storms are expected, please refrain from putting leaves out, as leaves can be washed into road ways, creating slick and dangerous conditions. Leaves may also clog storm drain catch basins and cause road flooding. Do not place sticks and branches in your leaf piles as the Borough uses a leaf vacuum that is not designed to pick up anything other than leaves.

Because the vehicle and equipment used for leaf collection can be hard to maneuver around cars and other objects, piles of leaves placed too close to or under vehicles will not be picked up. Additionally, leaf piles on curves and bends may not be collected because curves and corners cause sight distance issues for drivers.

Please place your leaves in the same location as your refuse containers. Special pickups may be granted by the Borough by placing a call to the Streets Department office @ 717-252-4559 Please confirm the pickup location is acceptable prior to putting leaves out.

In accordance with Chapter 6, Part 3, §307 of the Code of Ordinances, remember to always clean up after your dog to avoid creating an animal nuisance. Additionally, Chapter 2, Part 1, §102 states that allowing your cats/dogs to run at large within the Borough is prohibited.

## **Borough Code of Ordinances to keep in mind this season...**

### **SNOW & ICE ON SIDEWALKS**

Chapter 21, Part 3, §301

Within the Borough limits, property owners are required to remove all snow and ice from the sidewalks within 24 hours after the snowfall has ended.



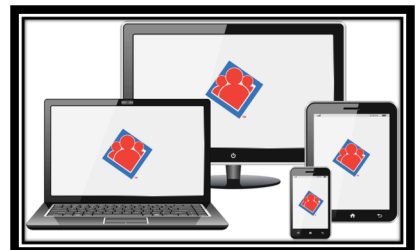

# PUBLIC WORKS

Dear Resident:



Providing safe roads for all Wrightsville residents requires a team effort. We are lucky enough to have a dedicated team comprised of men that are ready, willing and able to work extensive hours and perform highly tedious and strenuous work to combat the cold and dangers of winter. You, the Wrightsville taxpayer and resident, are an integral component to a successful snow and ice control crusade. Your consideration and cooperation are very important to the Borough. Please remember that snow removal operations are being performed in order to provide a safe environment for us all.

Here are some tips that may help you to avoid the headaches of shoveling...

- ◆ If at all possible, we encourage you to wait until the plows have completed curb to curb plowing on your street. In the very least, shovel everything in your driveway with the exception of the last six feet of your driveway. We recommend that you finish clearing your driveway entrance **after** the final widening pass has been completed. This will help to prevent our plows from pushing snow back onto your property.
- ◆ Try to park all vehicles in driveways and off the street so that our crews are able to plow back to the curb.
- ◆ Portable basketball nets projecting into the roadway are prohibited and can be dangerous during snow plowing.
- ◆ Place some reflective tape on your mailbox, enabling them to be better seen by those plowing.
- ◆ Be mindful of pedestrians following a snowfall. Please be aware that Borough Ordinance requires snow and ice to be removed from sidewalks within 24 hours after the snowfall.
- ◆ Helpful Hint: The final widening pass is usually completed approximately 8 to 10 hours after the snow stops completely. This, of course, depends on the severity of the storm.
- ◆ Be patient and allow those plowing to do their jobs. Safe streets are a primary concern for the Borough during the winter months. We thank you for your patience and understanding.

**Know what to do **before** all those beautiful white flakes cover our streets and take up our parking spaces!**

## SNOW EMERGENCY FAQs:

**Are snow tires or chains required?** Yes.

**What is the point of restricting parking during a Snow Emergency?** Borough plows need sufficient space to push snow so that they can widen the road as much as possible in case of an emergency. Fire, police and ambulance vehicles need to get to their destination as quickly and as safely as possible.

**What if I decide not to remove my vehicle from the No Parking zone?** Your vehicle will be towed.

**Can I shovel the snow onto my street/alley?**

No. Doing so may result in the snow being plowed back into your parking space and receiving a fine of not more than \$1,000.

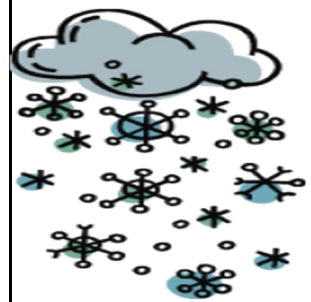

From the York County Economic Alliance (YCEA) website: "Trail Towns are communities adjacent to public trails that choose to embrace the trail as an opportunity for economic growth and improved quality of life." You may have noticed the trail, and many of its visitors, in the area of Front Street in Wrightsville. In York County, there are 7 trail towns: Glen Rock, Hanover, New Freedom, Railroad, Seven Valleys, Wrightsville, and York.

To raise local awareness of Wrightsville's Trail Town designation, and as part of the winter holidays celebrations, a group of residents in Wrightsville is organizing a bicycle decorating competition. A big "Thank you!" goes to the sponsors of the event, Sue's Market and Burning Bridge Tavern. Another big "Thank you" goes to Mayor Tayne Slenker who has graciously agreed to be one of the judges. Additional judges will be announced soon.

The organizers of the event intend to reach out to trail towns on both sides of the Bridge, as well as York and Lancaster County Trail Town organizations, and invite residents to join in the competition. ## Wrightsville's Sept. 9 Community Yard Sale a Success By Christine Siksa

The Wrightsville citizen organizers of the somewhat impromptu 2023 community yard sale designed the advertising campaign to draw as many shoppers as possible from Wrightsville as well as the broader surrounding area. The notice was posted on the Borough website and on the Borough's outdoor sign located at the Columbia-Wrightsville Bridge. Special thanks to Eliseo for posting that sign and trimming the shrubs so it was more easily visible.

Additional advertising included Craigslist for York and Lancaster. A classified ad in The Merchandiser reached readers in Wrightsville, Hellam, Columbia, Hempfield, E-Town, Dover, Marietta and more. Another popular site was Facebook Events which reported "284 interested, 320 responded."

Some homeowners posted signs around town. Many of those sales were multi-family sales. Twenty-two sellers listed their locations through Facebook Events which included homes on Maple, Walnut, Locust, , Cherry, Hellam, North 2<sup>nd</sup>, Front, South 7<sup>th</sup>, Orange, and Willow Streets, plus Creekside Dr., Brook Ln (multi-family), and Sunset Road.

Customers were very friendly and had stories to tell about their search for specific items or for just plain good deals. Based on an informal survey, Craigslist sent most of the buyers to Wrightsville, followed closely by Facebook. The Merchandiser ad brought in buyers from Elizabethtown, Marietta and the Hempfield area.

Popular items were children's toys and clothes, collectibles and vintage items, tools, small furniture pieces, home and holiday décor, household goods, costume jewelry, and clothing. Early bird shoppers around 7 a.m., an hour before opening, ventured into still-unpacked boxes and made offers on whatever unusual things caught their eye. Many buyers were looking for items for their children's dorm rooms, their rental properties, or to freshen up the design at their own home.

Let's make the community yard sale an annual event! Next year's proposed dates for the Wrightsville Annual Community Yard Sale will include a Saturday both in the spring and fall, to be coordinated with other Borough activities. # SAFETY REMINDERS



## FALL DRIVING SAFETY TIPS

Autumn means we need to be more careful as drivers.

**WEATHER . . .**  
Sudden changes in temperature, rain, snow and fog all make for hazardous driving. Be aware of the weather - know before you go.



**SUNRISE and SUNSET . . .**  
Daylight Savings Time means the sun on the morning drive may be right in your eyes. The sun goes down early now, so it gets dark a lot sooner! **HEADLIGHTS!**



**CHILDREN and ANIMALS . . .**  
Children are back to school and animals are busy preparing for winter. Look out for them. Slow down, keep an eye out, and be kind.



**LEAVES . . .**  
Leaves on the ground can be slippery and dangerous. Careful when driving on leaf-covered roads, whether it's raining or not. Make sure and clear leaves off your car before driving.



## The Importance of Smoke Detectors

Over 1/3 of home fire deaths occur in homes that had non-operating or no smoke detectors at all. Most victims die from the smoke and gasses not the flames from the fire itself.



## FIRE SAFETY DURING THE HOLIDAYS!

Short circuited tree lighting is the leading cause of fires started by a Christmas tree. If purchasing an artificial tree to celebrate, make sure you purchase one with a fire retardant label.

When using a natural tree, the greenest and freshest ones are the best. It is very important to water it daily. A six foot tree will absorb a gallon of water every two days. A watered green tree will be resistant to flames and less likely to ignite. Always remember to unplug all lights when not in use.



## Fireplaces and Chimneys

Chimneys are a great addition to the look of a home - but they serve a very important purpose. They are designed to carry dangerous gases from a fireplace or furnace out of the home. Black tar called creosote builds up in the flue and is highly combustible.

When the debris that is built up inside a chimney ignites, it burns at extremely high temperatures and breaks down vital components of the chimney; thus causing extension into the walls of the home and may extend throughout the whole house.

Your chimney should be cleaned out regularly. Especially before each cold season. There are many chimney sweep kits available to help you do this as well as companies that do this type of thing professionally.

# EFFECTIVE STORMWATER MANAGEMENT

## WHAT IS ALL OF THIS HYPE ABOUT STORMWATER?

Residents may have noticed the increasing regulatory stipulations pertaining to stormwater and rain runoff.

The Borough is covered under a federally required permit and is therefore obligated to perform specific tasks in order to keep our stormwater system clean and protect the watershed.

This program is called the National Pollutant Discharge Elimination System (NPDES) and is comprised of six elements, requiring a cooperative effort between the municipal departments, Borough officials, local, state and federal agencies and you, the resident.

The six required principles of the NPDES permit are called the Minimum Control Measures:

1. Public Education/Outreach

2. Activities such as the marking of storm drains, community clean ups and resident Adopt-A-Drain programs.

2. Public Involvement/Participation

Activities such as outfall inspections, investigations of illicit discharge complaints and participation in household hazardous waste collection events.

3. Illicit Discharge, Detection & Elimination

Activities such as outfall inspections, illicit discharge complaint investigation, and participation in household hazardous waste collection events.

4. Construction Site Runoff

Activities such as inspecting active sites, requiring drainage/maintenance agreements, and reviewing plans.

5. Post-Construction Runoff

Activities such as inspecting stormwater management areas, and performing maintenance on stormwater

# PERMITS

## ZONING AND BUILDING PERMITS

All Zoning and Building permit paperwork is processed at the Borough office. Payment for both will also be collected at the Borough. If your project requires both a Zoning and Building Permit you will need to pay for each permit separately. Permit fees do not need to be paid until permit is approved and picked up.

### DO I NEED A PERMIT?

**It is unlawful for any person, firm or corporation to erect, construct, enlarge, alter, move, improve, remove, convert or demolish any building/structure without a permit.**

**NO WORK CAN BE STARTED UNLESS PERMIT IS ISSUED FROM BOROUGH OFFICE!!**

### PROOF OF INSURANCE



Proof of Insurance is required on all projects in the form of a **Certificate of Liability** listing **Wrightsville Borough** as the **certificate holder**. If a contractor is doing the work, their liability insurance information is required. If a contractor is not employed, the homeowner must provide a copy of their homeowners insurance in the form of a certificate of liability. This is typically called an ACORD file.

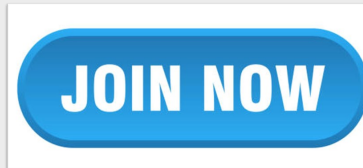

### RAVE INFORMATION

In our efforts to provide more reliable communication with residents and businesses, we have implemented RAVE as our Emergency Notification System.

RAVE in its simplest form is a system that makes phone calls to specific people or areas in the event of an emergency or for sharing important information. All calls you receive will have Caller ID of "Wrightsville Borough Municipal Authority".

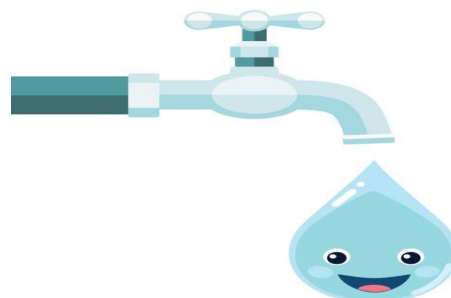
