The Planning Meeting of the Borough of Wrightsville governing body convened at 6:31PM on Monday, July 16, 2018. Council President White called the meeting to order and led the salute to the American Flag.

ACTION ITEMS:

Vice President Gromling made a motion to transfer borough personal property identified in Exhibit A and Exhibit B to Hellam Township under the terms of a Police Services Agreement ratified by the adoption of Resolution 2018-19. Councilman Bair seconded the motion. All in favor. The motion carried with a unanimous vote.

BOROUGH COUNCIL COMMITTEE REPORTS:

ADMINISTRATION & FINANCE:

President White relayed to those in attendance that final payments have been made to the 3 full time officers to satisfy Collective Bargaining Agreement. Final payments were issued on July 16, 2018.

Vice President Gromling and Councilman Smith will inventory remaining items left at police station to determine what to do with remaining property.

Public Works:

Vice President Gromling indicated that an abundant amount of nails are being found at construction site at 2nd Street and Locust Street after construction crews leave site. Councilman McDonald stated that the workers need to be made aware of this matter.

Vice President Gromling relayed to those in attendance that the Locust Street Project was placed on PennBID for proposals. VP Gromling stated that project costs will exceed grant money being awarded and the borough would need to borrow additional finances of \$200,000 to fund the remaining balance of project costs.

Public Safety:

Councilman McDonald relayed to those in attendance that the letter that was sent to borough residents in reference to violations has helped and he is noticing improvements in borough.

Vice President Gromlig relayed to those in attendance that a meeting was held with County Line Quarry to discuss multiple concerns with truck speed in borough. VP Gromling and Councilman McDonald relayed that they have noticed a decrease in truck speed since meeting.
